





USB Type C Cable




USB Type A-to-C Cable

1.4 Warnings and Notices

Please read the following before using the product.

General Care

- Avoid placing the unit close to large magnetic devices, high voltage devices, or near a heat source. This includes any place where the product will be subject to the greenhouse effect, such as the interior of a car on a warm, sunny day.
- We strongly recommend that you keep multiple copies of all your data on multiple devices. At least one copy of your data should sit on a disaster-resistant device like the ioSafe Solo Hawk or be offsite at a second location. The Solo Hawk allows you to move data offsite easily. No matter what the data storage device, keeping redundant copies of your irreplaceable data will improve your chances for data recovery.
- Do not disconnect the USB cable while the Solo Hawk is powered on without first stopping or ejecting the device through the operating system software interface. Disconnecting any drive during a read/write event can cause logical corruption on the drive which can sometimes result in data loss.
- Use proper surge and uninterruptible power supplies (UPS) to guard your computer system against abrupt outage and voltage spikes during brownouts and lightning storms.

About USB

- Actual connection performance depends on many factors including: CPU, file system overhead, number of attached devices and more. Given these and other factors, in day-to-day use you can expect maximum, sustained transfer rates to be less than the theoretical rates maximum rates possible with the connection.
- USB 3.2 is backwards compatible with USB 3.0 and USB 3.1 host computers.

NOTE

The cable supplied with your system has been optimized for performance. Longer cables may not work or only work intermittently.


STOP!

This device is not recommended for use with USB 2.0, as not enough bus power will be available to power the Solo Hawk.




2 Connecting the ioSafe Solo Hawk

- a. Connect a USB Type-C cable into the ioSafe Solo Hawk's type C port.



- b. Connect the other end of the USB cable into your computer. After a moment, the Solo Hawk will be detected by your computer.



Your Solo Hawk is now ready to use!

NOTE

If you are using the Solo Hawk with a Mac, you will need to reformat it so that you can write files to it. See Section 3 for information on how to format the SSD using macOS.



3 Usage with Windows and Mac Operating Systems

3.1 Usage with Windows Operating Systems

3.1.1 Formatting the Solo Hawk

Following the steps below for your specific Windows operating system to reformat your Solo Hawk.

NOTE

The Solo Hawk will work with Windows right out of the box without needing to format it. You may skip this section if you are setting up the Solo Hawk to work with Windows.

Windows 10

- Right-click on the **Start Button** and then select **Disk Management**.
- The drive should appear in the list of Disks in the lower pane. You may need to scroll down to see it. If the drive is already formatted, you can identify it easily by its volume name. If the drive is not initialized or is brand new, a window will pop up asking you to select a partition type. Select **GPT** and press **OK**.




Figure 7. The Disk Management pane with the Drive Properties Box highlighted in red.

- To format the volume, right-click the **Drive Properties Box** of the drive (highlighted red in Figure 7) and select **New Simple Volume...**

- Unless you wish to customize the settings in these dialog prompts, click **Next** on the Select Partition, Specify Volume/Partition Size, and Assign Drive Letter or Path dialog prompts, leaving the default settings.
- Choose your preferred file system from the file system selection window that appears and enter a name for the new volume. Then check the box labeled **Quick Format**, which ensures that the formatting process will take less than a minute.



- e. Click **Next** and then **Finish** to start the format process. When the format is complete, the Drive Properties Box will update to show the new volume name. The new volume can now be found by opening a File Explorer window and clicking on **This PC** in the navigation pane to the left.

Windows 8.1

- a. Press **WINKEY + X** and then select **Disk Management**.
- b. The drive should appear in the list of Disks in the lower pane. You may need to scroll down to see it. If the drive is already formatted, you can identify it easily by its volume name. If the drive is not initialized or is brand new, a window will pop up asking you to select a partition type. Select **GPT** and press **OK**.
- c. To format the volume, right-click the **Drive Properties Box** (highlighted in red in Figure #7) and select **New Simple Volume...**
- d. Unless you wish to customize the settings in these dialog prompts, click **Next** on the Select Partition, Specify Volume/Partition Size, and Assign Drive Letter or Path dialog prompts, leaving the default settings.
- e. Choose your preferred file system from the file system selection window that appears and enter a name for the new volume. Then check the box labeled **Quick Format**, which ensures that the formatting process will take less than a minute.
- f. Click **Next** and then **Finish** to start the format process. The new volume can now be found by opening a File Explorer window.

Windows 7




Figure 8. The Disk Management pane in Windows 7.

- a. Click on the **Start Button**, right-click the **Computer button** in the Start Menu, and then select **Manage**. In the left pane of the Computer Management window that opens, left-click on **Disk Management** (labeled 'A' in Figure 8).
- b. The drive should appear in the list of Disks in the lower pane. You may need to scroll down to see it. If the drive is already formatted, you can identify it easily by its volume name. If the Device Properties Box (labeled 'B' in Figure 8) says "Not Initialized", you'll need to initialize the disk before formatting it.

Right-click where it says "Not Initialized" and select **Initialize Disk**. If you are prompted to select a partition type, select **GPT**.

- c. To format the volume, right-click the Drive Properties Box (labeled 'C' in Figure 8) and select **New Simple Volume...**

- d. Unless you wish to customize the settings in these dialog prompts, click **Next** on the Select Partition, Specify Volume/Partition Size, and Assign Drive Letter or Path dialog prompts, leaving the default settings.
- e. Choose your preferred file system from the file system selection window that appears and enter a name for the new volume. Then check the box labeled **Quick Format**, which ensures that the formatting process will take less than a minute.
- f. Click **Next** and then **Finish** to start the format process. When the format is complete, the Drive Properties Box will update to show the new volume name. The new volume can now be found by clicking on the **Computer button** in the Start Menu.

3.1.2 Accessing or Disconnecting the Solo Hawk in Windows

Accessing the Solo Hawk

When the Solo Hawk is properly connected and turned on (see Section 2), a window may open to allow you access to the volume.

If no window appears and you are using Windows 10 or 8.1, find the volume by opening a File Explorer window and then clicking on **This PC** in the navigation pane of a File Explorer Window (Windows 10) or clicking on **Computer** in the navigation pane of a File Explorer Window (Windows 8.1). If using Windows 7, click on the **Computer button** in the Start Menu instead.

Disconnecting the Solo Hawk

Unmount the Solo Hawk before powering it down. Left click the **USB plug icon** with the checkmark on the Desktop task bar and select the Solo Hawk from the menu that pops up. You may have to click on the **Show Hidden Icons arrow** on the task bar to find the



correct icon. Windows will indicate when it is safe to disconnect the USB cable from the Solo Hawk.

NOTE

Disconnecting the Solo Hawk while Windows is actively reading or writing to the volume can result in data loss. Wait for the Status Light to stop blinking before disconnecting it.

3.2 Usage with macOS

3.2.1 Formatting the Solo Hawk

To format a hard drive or SSD, use Disk Utility (see Figure #), which can be found in **Applications** → **Utilities**, or by selecting **Spotlight Search** and typing in “Disk Utility” and hitting **Return** on your keyboard.

- Click on the drive in the window to the left.
- Click on the **Erase** button at the top.
- Enter a name for the new volume.
- Select the format type. Select **APFS** if it is an available option. Otherwise, select **OS X Extended (Journaled)**. If you need to use your Solo Hawk with both macOS and Windows computers, select **ExFAT** instead.
- For the scheme, select **GUID Partition Map**.
- Click **Erase** to start the process.
- Once the format is complete, click **Done**.

3.2.2 Accessing or Disconnecting the Solo Hawk in macOS

If the Solo Hawk is already formatted, an icon representing it will appear on the desktop. You can begin using the Solo Hawk right away. If it's unformatted, a message will appear on the desktop saying that the disk is unreadable. Use Disk Utility to easily format the drive (see Section 3.2.1).

Eject the Solo Hawk before powering down the unit by dragging the Solo Hawk's icon to the **Trash**, or by selecting the Solo Hawk's icon and then pressing **Command + E** on your keyboard.

NOTE

Disconnecting the unit without first unmounting the volume can result in data loss.


3.2.3 Create a Boot Drive

To create a boot drive, you must first install macOS on the Solo Hawk by using a third-party app like MacDaddy Install Disk Creator. Next, go to **System Preferences** → **Startup Disk**. A window will list the available bootable volumes. Select the volume from which you wish to boot. Another method is to hold down the Option key during boot up. A screen should appear that allows you to select the volume you wish to use. This is useful if you are sporadically booting from the Solo Hawk.



4 Securing the ioSafe Solo Hawk

For drive security, the ioSafe Solo Hawk is equipped with a Kensington security slot, which supports a standard Kensington security cable (sold separately). For more information on the Kensington security slot and available products, visit kensington.com.

Upon proper activation of your Data Recovery Service, qualified users can download:

Genie Timeline Professional (\$60 Value) – Award winning backup software for Windows. Simple, block level, open file and OS Continuous Data Protection (CDP) software for Windows users. DRS Activation is required at iosafe.com to validate purchase prior to downloading software and install code (see Section 6.1).

Apple® Mac® Time Machine® – Reformatting the Solo Hawk is required to use this software with macOS computers (see Section 3.2.1).

6.1 Activate Data Recovery Service Protection

Register your product to activate your Data Recovery Service protection plan and warranty by visiting iosafe.com/activate.

6.2 ioSafe No-Hassle Warranty

If the ioSafe Solo Hawk breaks during the warranty period, we will repair or replace it.

The standard term for the warranty is two (2) years from the date of purchase. A five (5) year extended term warranty service is available for purchase upon activation of the Data Recovery Service. See the website or contact customerservice@iosafe.com for help. CRU reserves the right to have its representative inspect any product or part to honor any claim, and to receive a purchase receipt or other proof of original purchase before warranty service is performed.

This warranty is limited to the terms stated herein. All expressed and implied warranties including the warranties of merchantability and fitness for a particular purpose are excluded, except as stated above. CRU disclaims all liabilities for incidental or consequential damages resulting from the use of this product, or arising out of any breach of this warranty. 6.3 Data Recovery Procedure

If the ioSafe faces possible data loss for any reason, you should immediately call CRU's ioSafe Disaster Response Team at 1-888-984-6723 extension 430 (US & Canada) or 1-530-820-3090 extension. 430 (International). You can also send an email to disastersupport@iosafe.com. CRU can determine the best actions to take to protect your valuable information. In some cases a self-recovery can be performed and provide you with immediate access to your information. In other cases, CRU may request that the product be returned to the factory for data recovery. In any case, contacting us is the first step.

The general steps for disaster recovery are:

- a. Email disastersupport@iosafe.com with your serial number, product type and date of purchase. If you cannot email, call the ioSafe Disaster Support Team at 1-888-984-6723 (US & Canada) or 1-530-820-3090 (International) extension 430.
- b. Report the disaster event and obtain return shipping address/instructions.



- c. Follow ioSafe team instructions on proper packaging.
- d. CRU will recover all data which is recoverable according to the terms of the Data Recovery Service Terms and Conditions.
- e. CRU will then place any recovered data on a replacement ioSafe device.
- f. CRU will ship the replacement ioSafe device back to the original user.
- g. Once the primary server/computer is repaired or replaced, the original user should restore the primary drive data with the ioSafe backup data.
